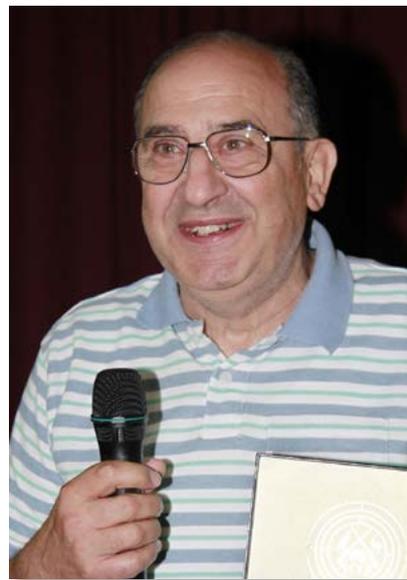

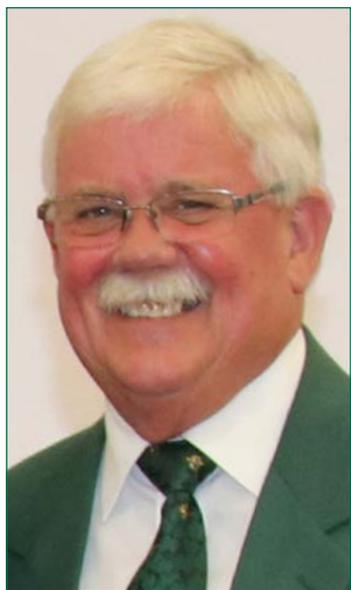

President's Report



ACTA President, Malcolm Dyson

It gives me great pleasure to deliver this, my first Annual Report as President of the Australian Clay Target Association (ACTA), on behalf of the National Executive. Since taking on this role there has been a smooth transition into the position. I have found the Association to be most welcoming and inclusive and while the initial stages have had their challenges, it has been through the support of members at all levels, administrative and general, that have ensured that the ACTA has stayed strong and cohesive and well prepared for any challenges.

MEMBERSHIPS:

During the last twelve months memberships have increased from 13,646 to 13,692 – a small, but positive, increase of 46 members. 2,089 new members joined the Association, this is a reduced number of new members, down 285 from the previous year. Our Association membership shows no 'real' growth from year to year as we lose approximately the same number of members as we gain.

The intent of the Recreational membership category was to provide clubs with the opportunity to retain and grow membership, providing a 'target only' classification. This category gives Recreational members the opportunity to be exposed to competition shooting with a desired outcome, leading them to full membership. In an effort to build Association membership a club membership incentive scheme is being introduced for the 2020 membership year to assist clubs to increase new members and retain lapsed members. Clubs that are able to increase their 2020 membership by more than 20% from their membership level as at the 30th October 2019 (baseline) will receive \$30 reimbursement from the ACTA for each member registered above the 20% increase from the 2019 figure.

This incentive endeavours to encourage clubs to seek new

members through financial bonus but will also assist ACTA through an increase in membership numbers.

FINANCIAL:

The Association has reported a net deficit of \$119,747 for the current financial year. This compares to previous financial results as follows:

2019	(\$119,747)
2018	\$1,493,290
2017	\$4,359,192

The 2018 and 2017 financial results had been significantly inflated by the one-off capital funding received from Infrastructure NSW to assist with the construction of the ACTA Function Centre.

2019 also represents the first full year of the Function Centre operations including the associated annual depreciation charge. The Association has recognised a total depreciation expense of \$349,863 for the 2019 financial year.

The ACTA held total cash reserves of \$1,047,243 at the year-end which is an increase of \$295,714 since 31st December 2018.

NATIONAL CHAMPIONSHIPS:

All National Championship events conducted during the year were very well attended. The support of members at National events is most encouraging and provides not only an opportunity for intense competition and rivalry but also a chance for National Executive in attendance to meet with ACTA members.

The National DTL Championships were held at the Roma Clay Target Club, with a very creditable 440 competitors attending. Congratulations to Roma President Andrew Whyte and his committee in delivering an excellent and entertaining Carnival. Congratulations to Phil Grainger on winning 2019 High Gun. The National Skeet Championships

held at the National Ground (Wagga Wagga) was also very well attended attracting 160 competitors from all over Australia. Congratulations to High Gun winner Glenn Clarke.

The National ISSF event held at Brisbane Gun Club was also well attended. Aislin Jones made history when she became the first female shooter to win the High Gun title in Skeet. James Willett won the Men's Trap High Gun and Penny Smith won the Women's Trap High Gun.

National Sporting Clays this year was held at Whiteman Park, Perth WA. With a small field of 57 competitors this was a little disappointing. Chris Brown, from the Maryborough Club in Victoria, was the Overall Champion.

COACHING:

The ACTA, by confirmed right, have resumed the control of ACTA Coaching Accreditation.

The ACTA Executive have again introduced a Coaching Sub-Committee. A National Coaching Committee will comprise of the members of the Sub-Committee and each State Coach. This National Coaching Committee will appoint a National Chairperson from within the group and this group will be charged with the decision making process in relation to the National coaching program.

On behalf of the ACTA Executive and members I would like to acknowledge and thank Suzy Balogh for the time and effort she has contributed to ACTA coaching.

ADMINISTRATION:

The National Office has seen several changes during the year with the resignation of Chief Executive Officer Paul McLoughlin, and the appointment of Paul Gilbert to the position.

After 15 years with the Association, Maureen Ryan decided to retire. I would like to take this opportunity to thank Maureen for her dedication and

application to the position and wish her well for her future endeavours.

Incoming CEO, Paul Gilbert, has reassessed the administrative positions and as a result Sue Vesperman has been assigned to memberships, Judy Ferry remains in finance; in the administration area we welcome Aileen Storey to general office responsibilities including the specific role of administration of the Function Centre and Jenny Robinson has been appointed to the position of reception/administration in a part-time capacity.

The outside staff have also had changes with Ewan McLachlan resigning, to change occupations. The Association has employed two maintenance and ground staff members working a 30-hour week. This allows ample allocation of time to maintain the National Ground and service the Function Centre.

SPONSORS:

The ACTA are most grateful for the exceptional support provided by the Association's sponsors. Sponsorship was received from Casella Wines, Bronze Wing, Beretta Australia, Perazzi Australia, Winchester Australia, Clay and Hunt, On Target, Outdoor Trading Company, Hunt Sporting Supplies, Mialls Gun Shop, Power Ammo, BEST and PCM Enviro. The Association takes this opportunity to thank these major sponsors for all their efforts and looks forward to their ongoing support.

FUNCTION CENTRE:

During 2019, the Function Centre averaged around 3 events per month. This included school presentations, trade fairs, seminars, career expos and other community events. Income generated from catering was \$65,527 and hire of the centre was \$65,542.

With the appointment of Aileen to concentrate on the Function Centre,

her knowledge and experience of media and marketing has already seen excellent bookings for 2020. The Function Centre continues to be a very positive investment.

ACTA FUTURE:

ACTA Executive has appointed Brisbane Company CPR Group to conduct a Strategic Planning Process with the outcome to be a National Strategic Plan. Previously there has been no definitive forward planning documentation and this process aims to prepare a clear plan to provide direction for the current, and future, National Executive members and administrators to ensure the long-term viability of the organisation.

A Constitution Sub-Committee has been formed to revise and update the ACTA Constitution. This committee is working towards presenting a new Constitution to our membership in 2021. Updates will be provided throughout the year to give members the opportunity to provide input into this documentation and will form an essential element of the Constitutional review process.

I would like to take this opportunity to thank our staff and fellow Executives for their support, time and effort during the year. A special thanks to Vice Presidents Gary Read and Terry Marsden, also a special thank you to retiring President Robert Nugent. In closing, thank you to all members within our Association who have volunteered their time and work at all levels - Club, Zone and State. Your contribution to our Association is gratefully received. With your effort our Association remains strong.

Chief Executive Officer's Report



ACTA CEO, Paul Gilbert

As most of you would be aware, 2019 saw changes in management at the ACTA at a number of levels. Firstly, the CEO appointed at the end of 2018, Paul McLoughlin, only remained in this position for six months, then in August, our President, Robert Nugent stepped down to be replaced by our previous Vice President, Mal Dyson. This left two new managers at the helm with a very steep learning curve and many things to bring back up to speed. My first acknowledgement therefore needs to be made to Judy Ferry, who, in a period of high tension and turmoil, worked tirelessly with Robert to keep the Association buoyant and moving forward during that couple of months of transition. I would also like to take this opportunity to thank those of you who have lent input, counsel and support to me during recent months and helping me to obtain some clearer perspective moving forward.

STAFFING

One of the major things that happened during the previous CEO's appointment was the re-scoping of positions, tasks and duties within the National Office. This process did not occur without casualty, and a number of revisions were made to job descriptions and reallocation of tasks. As a consequence, the Reception role was terminated in June with those duties re-absorbed by the three administration staff, Maureen, Judy and Sue. Then in August, Maureen decided that she would like to retire at the end of the year. This gave me the opportunity to reassess the positions yet again, at which time I consulted with staff to determine the best formula for the Association. As a result, Sue took over the Membership Administration, Judy remained in Finance, a new employee, Aileen Storey was appointed to concentrate on the Function Centre, Media and

Marketing, then at the end of the year, Jenny re-accepted a role in part-time Reception/Admin support.

As you were advised in the last Annual Report, a full-time Maintenance and Ground staff position commenced in 2018. In April 2019, Ewen McLachlan stepped into this role following Marcus Pim's departure, then in September, Ewen decided to resign so he could change occupations. Again, looking at the needs of the Association, it was determined at this time that the Function Centre, (set up/pull down/cleaning), was absorbing, on average, around 2 days per week of this employee's time, which was leaving insufficient hours to properly maintain the National Ground. This resulted in the employment of two thirty-hour-per-week Maintenance and Ground staff members, which now allows ample allocation of prioritisation to both of these valuable assets. John and Brenton are now both up to full speed and delivering a valuable contribution to the Association.

It would be remiss of me to not acknowledge Maureen's time as an employee with us. Maureen commenced with the ACTA in November 2004 in the reception role. At the commencement of 2010, she formally commenced in the Membership Services role where she remained until her retirement on 13 December 2019. When discussing her achievements, Maureen expressed her satisfaction with a full 49 years of continuous working life, which is an amazing accomplishment. I am sure you join with me in thanking Maureen for her contribution to this Association and wish her a happy, healthy, long and enjoyable retirement.

COMPETITIONS

2019 saw another "unusual" year with regard to domestic competition.

Following 2018 where our Trap Nationals were integrated with a World DTL Championship, 2019 saw the Trap Nationals travel to Roma in Queensland. This event was strongly supported by our members, 429 Australian competitors in total with an additional 9 international guests. Congratulations to the Roma Clay Target Club, their President Andrew Whyte and his great team who delivered an exceptional event. Many people I have spoken with were extremely complimentary of the extensive social program that accompanied the Championships which provided the participants and their families an array of entertainment opportunities across the entire week. Our Skeet and Sporting Clays events, while less in number, were also successful competitions. Participation numbers were steady for all Nationals and events were strongly contested.

EXECUTIVE COMMITTEE

As I reported in my opening paragraph, Robert Nugent (ACTA President from 2015 – 2019) stood down from this position at the August Executive Committee Meeting. This was Robert's second stint in the President's role. While I wasn't an employee during Robert's time in leadership, it is obvious that he has left a lasting legacy to the Association. His devotion to the Association and energetic contribution has always been paramount, and he was a pivotal and driving force in the delivery of the Range Function Centre. On behalf of the entire membership, I would like to thank Robert for his exceptional service to the ACTA over many years.

The ACTA continues to be managed by an Executive Committee comprised of two delegates per State who elect a President, two Vice Presidents, Secretary and a Treasurer. These Committee Members form

a Management Sub-Committee who meet regularly to act on urgent matters and present recommendations to the Executive Committee for approval. Our States also have Executive Committees who act on clay target business in their respective regions. I would like to acknowledge all of these members who generously and selflessly volunteer their time to the sport, as well as Zone and Club Committee Members and volunteers who contribute so strongly to the delivery of membership events and services to our registered members.

FUTURE DIRECTION

In March 2020, the ACTA has engaged the services of CPR Group to facilitate the preparation of our first Strategic Plan. The process will help the Association examine where we are, where we want to go, and how we are going to get there. We hope to obtain input from members through their Clubs, Zones and States by way of a survey which has already been distributed, following which the Executive Committee will attend a planning day and develop the action plan.

Additionally to this, the Association is again working to revise and update the Constitution. A Constitution Sub-Committee has been formed with a view to presenting the new Constitution to our membership in early 2021. While this is not the first time the ACTA has attempted to update its Constitution, there appears to be a strong ambition to deliver a Constitution that is more relevant to our needs and requirements, and we thank the Constitution Sub-Committee for their input and contribution.

In closing, I would like to thank the Executive Committee and my staff for their support and assistance in my first five months at the Association. I see many passionate people working

for and with the Association, many of whom have a strong belief in the organisation they serve. I hope we can continue to realise and deliver better and more valuable membership services to you, our members, as we move into 2020.

PRINCIPAL ACTIVITIES

The principal activity of the Association during the 2019 financial year was to administer, promote and develop the sport of clay target shooting.

RESULT

The net operating deficit of the Association for the year ended 31 December 2019 was \$119,747. This compares to a net operating surplus in 2019 of \$1,493,290 (with one-off capital funding of \$1,413,205).

STATE OF AFFAIRS AND SIGNIFICANT EVENTS

The Committee note that the ICTSF World DTL Championship ISSF Nationals were both held at the National Ground in 2018, resulting in a significant increase to operating revenue for that year.

In the opinion of the Committee there were no other significant changes in the state of affairs of the Association that occurred during the financial year under review not otherwise disclosed in this report or the accounts.

EVENTS SUBSEQUENT TO BALANCE DATE

There has not arisen in the interval between the end of the financial year and the date of this report, any item, transaction or event of a material and unusual nature likely, in the opinion of the Committee of the Association, to affect significantly the operations of the Association, the results of those operations, or the state of affairs of the Association in subsequent financial years.

SHORT AND LONG TERM OBJECTIVES

The short term objective of the Association is to service its members through:

- Organisation of local, state, national and internal competitions,
- Ongoing coaching and development,
- Collaboration with State Associations and affiliated Clubs.

The long term objectives of the Association are to promote the sport, service its members and to work collaboratively with all state organisations to manage the future development of the sport.

KEY PERFORMANCE INDICATORS

The Association monitors key performance indicators against industry standards and internal expectations. The indicators are both financial and non-financial with the results presented for the Committee's discussion.

LIKELY DEVELOPMENTS

The Committee is planning to reassess the ongoing valuation methodology of the property, plant and equipment held by the Association in the coming financial year.

COMMITTEE INTERESTS AND BENEFITS

Since the end of the previous financial year no Committee member has received or become entitled to receive any benefit because of a contract made by the Association or a related corporation with a Committee or with a firm of which a Committee member is a member, or with a company in which the Committee has a substantial interest.

NOTES TO AND FORMING PART OF THE ACCOUNTS

For the Year Ended 31 December 2019

NOTE 1 - STATEMENT OF ACCOUNTING POLICIES

The financial report includes the financial statements and notes of the Australian Clay Target Association Inc as an individual entity. The Australian Clay Target Association is a not for profit entity incorporated and domiciled in Australia. These financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements and the financial reporting requirements of the Associations Incorporation Reform Act 2012.

The following is a summary of the material accounting policies adopted by the entity in the preparation of the financial statements:

(a) *Income Tax*

No provision for income tax has been raised as the entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(b) *Cash and cash equivalents*

Cash and cash equivalents comprise cash on hand and demand deposits, together with other short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

(c) *Receivables*

Accounts receivable include amounts due from members. Accounts receivables are recognised at the amounts as they are due for settlement. Accounts receivables do not carry any interest and are stated at their nominal value.

(d) *Inventories*

Inventories comprises goods for resale and goods for distribution and use at no or nominal consideration as part of the Association's ongoing activities.

Inventory held for sale is measured at the lower of cost and net realisable value.

(e) *Trade creditors and other payables*

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period, which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days on recognition of the liability.

(f) *Property, plant and equipment*

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment.

Where the cost model is used, the asset is carried at its cost less any accumulated depreciation and any impairment losses. Costs include the initial purchase price and other directly attributable costs.

Land

Land held for use is stated at re-valued amounts. Revalued amounts are fair market values based on appraisals prepared by external professional valuers once every three to five years or more frequently if market factors indicate a material change in fair value.

Increases in the carrying amount arising on revaluation of land and buildings are recognised in other comprehensive income and accumulated in the revaluation surplus in equity. Revaluation decreases that offset previous increases of the same class of assets shall be recognised in other comprehensive income under the heading of revaluation surplus. All other decreases are recognised in profit or loss.

Buildings, plant & equipment

Buildings, plant and other equipment (comprising fittings and furniture) are initially recognised at acquisition cost, including any costs directly attributable to bringing the assets to the location and condition necessary for it to be capable of operating in the manner intended by management.

Buildings, plant and other equipment are subsequently measured using the cost model, cost less subsequent depreciation and impairment losses.

Depreciation is recognised on a straight-line basis to write down the cost less estimated residual value of buildings, plant and other equipment. The following useful lives are applied:

(g) *Revenue*

The Association applies AASB 15 for recognising revenue. Revenue is recorded as the amount of the transaction price that is allocated to the performance obligation, excluding any amounts of variable consideration, when the performance obligation has been satisfied. All revenue is stated net of the amount of goods and services tax (GST). The Association has the following specific policies for when the performance obligations have been met:

Provision of Membership Services

Revenue for membership subscriptions is recognised in the period to which the benefits of the membership is provided.

Sale of Goods

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Capital grants

Capital grants received to enable the Association to acquire or construct an item of property, plant and equipment to identified specifications which will be under the Association's control and which is enforceable are recognised as revenue as and when the obligation to construct or purchase is completed.

For construction projects, this is generally as the construction progresses in accordance with costs incurred since this is deemed to be the most appropriate measure of the completeness of the construction project as there is no profit margin.

For acquisitions of assets, the revenue is recognised when the asset is acquired and controlled by the Association.

Donations

Donations collected, including cash and goods for resale, are recognised as revenue when the Association gains control of the asset.

Interest revenue

Interest income is recognised on an accrual basis using the effective interest method.

(h) *Goods and services tax (GST)*

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of an asset or as part of an item of expense. Receivables and payables are stated inclusive of GST.

(i) *Employee benefits*

A provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

The Association's liabilities for other employee obligations are included in other long-term benefits as they are not expected to be settled wholly within 12 months after the end of the period in which the employees render the related service.

(j) *Reserves*

Asset revaluation reserve comprises gains and losses from the revaluation of land.

All other reserves comprise surplus funds that have been designated to be spent for a specific purpose in the future to which the individual reserve relates.

(k) *Financial Instruments*

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions of the instrument. For financial assets, this is equivalent to the date that the entity commits itself to either purchase or sell the asset (ie trade date accounting is adopted). Financial instruments are initially measured at fair value plus transaction costs except where the instrument is classified 'at fair value through profit or loss' in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Finance instruments are subsequently measured at either fair value or amortised cost using the effective interest rate method or cost. Fair value represents the amount for which an asset could be exchanged or a liability settled, between knowledgeable, willing parties. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as:

The amount at which the financial asset or financial liability is measured at initial recognition less principal repayments; plus or minus the cumulative amortisation of the difference, if any, between the amount initially recognised and the maturity amount calculated using the effective interest method; and less any reduction for impairment.

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the

contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying value with a consequential recognition of an income or expense in profit or loss.

(i) Financial assets are classified at fair value through profit or loss

When they are held for trading for the purpose of short-term profit taking, or where they are derivatives not held for hedging purposes, or when they are designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Such assets are subsequently measured at fair value with changes in carrying value being included in profit or loss.

(ii) Loans and Receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

(iii) Financial Liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

Impairment

At each reporting date, the entity assess whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the statement of comprehensive income.

De-recognition

Financial assets are derecognised where the contractual right to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

(l) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where the future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of assets, the entity estimates the recoverable amount of the cash generating unit to which the class of assets belong. Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

(m) New Accounting standards adopted during the year

AASB 15 Revenue from Contracts with Customers

AASB 15 took effect for the Association on 1 January 2019, replacing AASB 118 which details the recognition of revenue. Under the new standard revenue is recognised when specific performance obligations are met. The adoption of this standard has resulted in a change in when the Association recognises revenue from membership subscriptions. This income is now recognised in the period to which the membership is provided, previously the income was recognised on a cash basis.

AASB 16 Leases

AASB 16 took effect for the Association on 1 January 2019, replacing AASB 117. The new standard removes the distinction between operating and finance leases, consequently the majority of leases will be recognised on the balance sheet. Under the new standard, an asset (the right to use the leased item) and a financial liability to for future rental payments are recognised. This standard did not have a material impact on the operations of the Association.

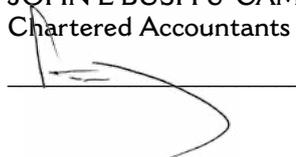

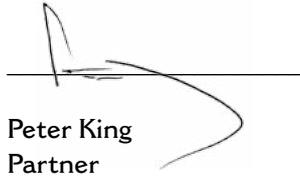

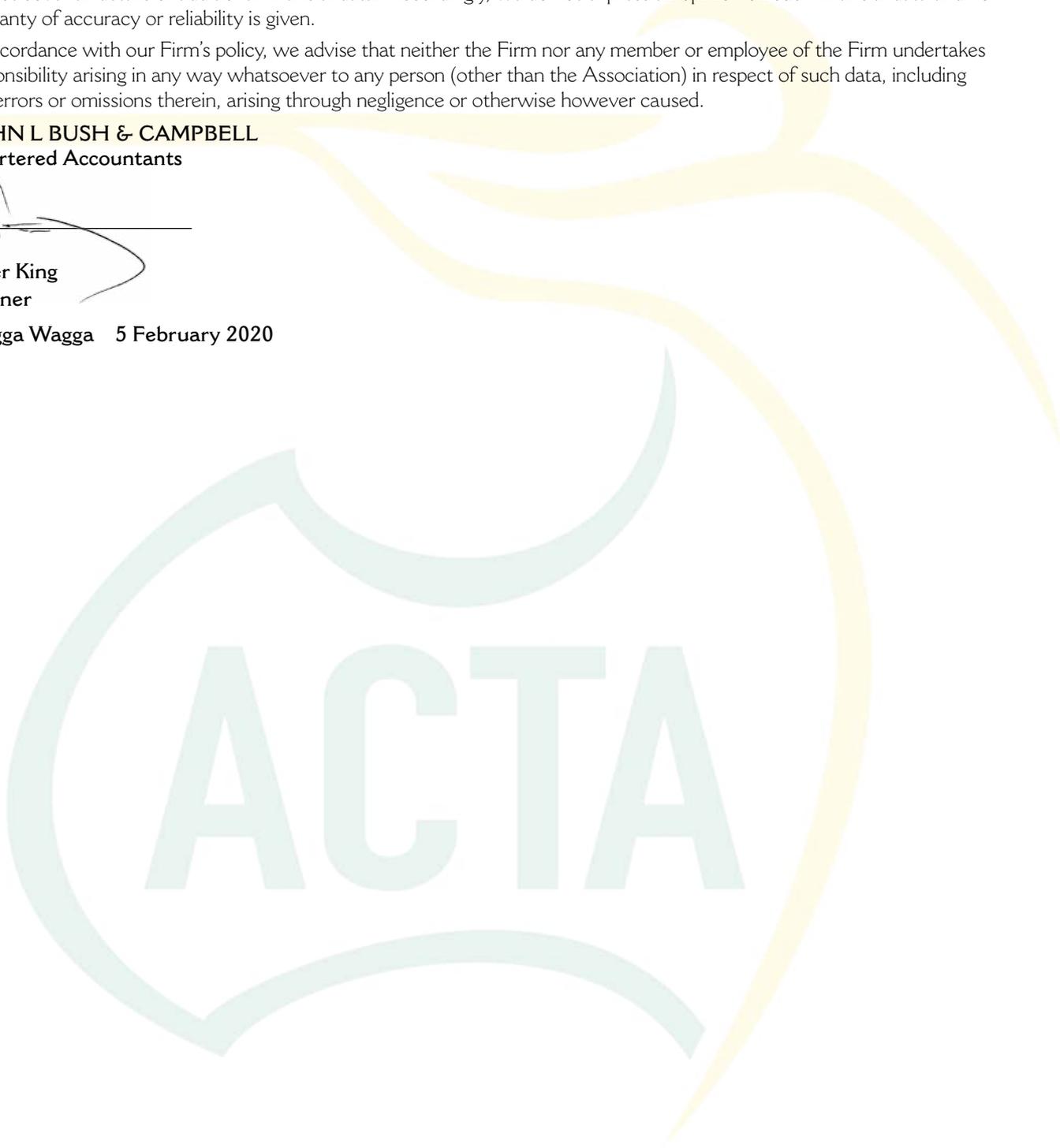

2020 ACTA Rule Book

After receiving recommendations for Rule changes from State Associations, State Rules Supervisors and State Handicappers, a National Rules Conference was convened at the ACTA Office in Wagga Wagga in June.

Following on from this, recommendations were forwarded to the National Executive for ratification at their August meeting.

Most recommendations were approved by the Executive and the new Rule Book came into effect in January 2020.

Two important new Rules which members will need to be aware of are those relating to the grading of Double Rise targets and the need to record all Trap scores shot from metreages other than fifteen.

New Handicappers' Course

The introduction of a Handicappers' Course is still a work in progress and needs some tweaking around the new Double Rise section before being made available to all States in 2020.

The National Handicapper has noted his concern at the amount of clubs not updating the ACTA database. This is a task that clubs must take seriously, as the consequence of not updating will mean that many shooters arrive at competitions to find that the wrong information has been downloaded. Many shooters' Record Cards also carry information that has not been updated.

2019 COACHING REPORT

ACTA Coaching is in the process of a change in direction, which will see the States having more input and control in the development of coaching in their individual States and in the National programs.

This will be achieved by the formation of a Coaching Directors/Co-ordinators panel with representation from all States and will work with the reformed National Coaching committee to develop coaching accreditation pathways and general coaching programs.

There will be an allocation of funding to each State with the ability of States to apply for funding for a specific coach and general coaching programs that they wish to conduct.

I would encourage members that have any thoughts on coaching pathways in their State to talk to their coaching Director/Co-ordinators who can assist them in this process.

I would also encourage any member who desires to become a coach, at any level, to contact their State for assistance in the location of courses.

In closing I would like to thank Suzy Balogh for the work she has done as the National Coaching Director, it was very much appreciated, and I wish her well for the future.

NATIONAL GROUND AND THE RANGE FUNCTION CENTRE

2019 has been a year of consolidation for the Function Centre. Early in the year, the then-CEO performed a major staffing restructure, appointing Sue Vesperman into the role of Facilities and Events Officer. In addition to many of her ongoing membership administration duties and functions, a major part of Sue's new role involved the running of the Function Centre, including bookings, promotion, booking liaison, set-up and pull-down, cleaning, catering coordination, repairs and maintenance and annual programming. Needless to say, this expanded role was extremely complex, demanding and testing, requiring a steep learning curve and performance of a new skill set.

In order to assist Sue in the manual side of the delivery of the Centre, the Maintenance and Ground staff member was required to assist, and as bookings increased, this pulled that employee away from Ground maintenance tasks and into Function Centre set-up, pull-down and cleaning duties. As a consequence, that 38 hour position became, on average, 25 hours / week on the ground and 13 hours in the Function Centre plus frequent overtime hours. At this point it became very apparent that we were severely stretched and not able to adequately cover the scope of requirement. While meeting the Function Centre's base requirements, the Ground became visually unkempt and untidy. As a consequence, our newly-appointed Maintenance and Ground staff member, Ewen McLachlan, (who commenced in that role in April), became over-worked and only remained with us till August. While we were disappointed to have Ewen leave, this actually turned out to be a blessing in disguise, as it allowed us to reassess our needs in this combined area of

service delivery and appoint 2 new staff for a total of 60 hours per week (40 hrs / week Ground maintenance and 20 hrs / week Function Centre).

As a consequence, we have now been able to exponentially improve the delivery of facility maintenance services in both of these vital areas.

As was also reported in the CEO's Report, Maureen's retirement in December offered Sue the opportunity to return to a full-time Membership services role. A huge thank you is therefore owing and needs to be conveyed to Sue for performing her previous position with such great attention, devotion, effort and professionalism. As a result, we were then able to advertise and appoint Aileen Storey into the full time role of Media, Marketing and Functions Coordinator. Aileen was previously the Administration Manager with the Wagga Wagga Showgrounds, and she brings with her a wealth of experience and knowledge in the facilities delivery space. We welcome Aileen and anticipate that she will assist us to improve our performance in the delivery of the Function Centre moving forward. Nathan and Danette Gale of Wagga Catering Services continue to be our contracted Catering partner, and we are continuing to work closely with them to enhance the food and beverage service that the Function Centre so vitally provides.

In summary, the Function Centre hosted over 30 events in 2019, including school presentation nights and formals, Industry trade fairs and seminars, careers expos, wedding expos, industry dinners, conferences, hobby expos and community events, even including a christening and a wedding! The National Ground hosted Skeet and Military Nationals, NSW Championships across all disciplines, Wagga Wagga and Downside training and competitions and the Annual Stone-the-Crows Festival at Easter.

In all, over 20,000 participants visited our National Ground and enjoyed the facilities that we proudly own and operate.

A huge thank you to our previous and new Facilities staff for their devotion and energetic contribution, as well as our other staff who continuously provide ongoing assistance in the financial and logistical delivery of these wonderful facilities.
