Please use **BLACK PEN** and **CAPITAL LETTERS** to complete this form. Failure to make necessary amendments to pre-printed information AND complete all sections of this form may result in delay or refusal of your application.

The applicant for a Minor's Permit **MUST** be a minimum of 12 years of age, but no older than 18 years of age. This permit authorises the use of firearms under the supervision of a valid Firearms Licence Holder.

A Minor's Permit application **requires written consent** from a parent or legal guardian and **proof of identity for the minor** certified by a Justice of the Peace or a serving Police Officer. Refer to the FACT Sheet '100 Point Identification', available on the Firearms Registry Internet Site or by phoning the Firearms Registry, for acceptable documents.

FEF: If applying for A/B/C and H permits, two fees will apply as two permits may be issued. Complete the credit card authority on the back of the application or attach a cheque or money order payable to the Firearms Registry.

Minor's Permit for Category H Target Pistol. You must complete an approved course conducted by or on behalf of the target pistol club of which you are a current member and provide a certified copy of certificate issued.
