The applicant for a Minor's Permit MUST be a minimum of 12 years of age, but no older than 18 years of age. This permit authorises the use of firearms under the supervision of a valid Firearms Licence Holder.

A Minor's Permit application requires written consent from a parent or legal guardian and proof of identity certified by a Justice of the Peace or a serving Police Officer. Refer to the Supplementary Instruction sheet for acceptable documents.

Fee: If applying for A/B/C and H permits, two fees will apply as two permits may be issued. Complete the credit card authority on the back of the application or attach a cheque or money order payable to the Firearms Registry.

Minor's Permit for Category H Target Pistol. You must complete an approved course conducted by or on behalf of the target pistol club of which you are a current member and provide a certified copy of certificate issued.
